IP AND OFFENDER ARE CURRENTLY GOING THROUGH A DIVORCE BUT ARE STILL LIVING IN THE SAME ADDRESS. IP HAS REPORTED ONGOING VERBAL ABUSE BY OFFENDER WHERE THEY ARE ACCUSING IP OF WITCHCRAFT AND POISONING THEM.		

IP REPORTS HER CHILD HAS BEEN ASSAULTED BY 2 YOUTHS CAUSING AN INJURY TO HIS WRIST. SHE THEN STATES THAT SHE WENT TO SPEAK TO THE CHILD'S MOTHER IN THE STREET AND THE YOUTHS APPEARED WITH A LARGER GROUP AND VERBALLY ABUSED HER CALLING HER A WITCH CAUSING THE VICTIM HARASSMENT ALARM AND DISTRESS. *SECTION 40(2) EXEMPTION APPLIED*

IP HAS CONTACTED VICTIMS GATEWAY REPORTING THAT SHE HAS BEEN ASSAULTED. IP HAS STATED THAT SHE AS BEEN STABBED 3 TIMES TO THE REAR OF HER HEAD. SHE STATED SHE HAD NO RECOLLECTION OF THE EVENT, SUGGESTED THAT THE OFFENDERS WERE PART OF A WITCHCRAFT GROUP THAT TURN BLOOD IN TO A CLEAR LIQUID THAT WE CANT SEE. IP STATED THAT SHE WAS STABBED BY INVISIBLE PEOPLE. *SECTION 40(2) EXEMPTION APPLIED*

IP HAS BEEN HAVING ISSUES WITH THE SUSPECTS AND ON THIS OCCASION THE SUSPECTS HAVE CONTACTED THEM THROUGH SOCIAL MEDIA AND SAYING THAT THE IP IS A SEX OFFENDER. THE IP HAS ALSO BEEN CONTACTED BY ANOTHER PERSON AND HAS STATED THAT THEY WILL PERFORM AN EXORCISM AND THAT THEY ARE A HITMAN AND WILL TAKE THE IP OUT.

IP HAS RECEIVED NASTY COMMENTS AIMED AT HER, AT HER HUSBAND AND AT HER DAUGHTER. IP HAS BEEN CALLED A PSYCHOPATH, CRAZY COW, A BULLY, A WITCH AND KARMA NEEDS TO DO ITS STUFF AND IP WILL GET WHAT IS COMING TO HER. IP IS FEELING HARASSED. *SECTION 40(2) EXEMPTION APPLIED*

THE SUSPECT KNOCKED ON THE IPS DOOR AND ASKED IF SHE IS PERFORMING WITCHCRAFT ON HIM, HE HAS THEN POSTED A LETTER THROUGH THE IPS DOOR WHICH SUGGESTED HE WAS ANGRY WITH THE WHILST NEIGHBOURHOOD AND HE WOULD FIND OUT WHO IS PUTTING WITCHCRAFT ON HIM AND THAT HE WAS GOING TO FIGHT THEM ALL. THIS WEEKEND THE IP HAS RETURNED FROM HOLIDAY TO FIND A PLANT AND A SHRUB RIPPED OUT OF HER GARDEN AND BELIEVES THE SUSPECT TO BE RESPONSIBLE. *SECTION 40(2) EXEMPTION APPLIED*

IP MADE A CALL FOR SERVICE TO REPORT ONGOING ISSUES WITH YOUTHS IN THE AREA, AFTER ASKING THEM NOT TO PLAY FOOTBALL IN A COMMUNITY GARDEN. IP STATES THAT THEY VERBAL ABUSE HER AND CALL HER A WHITE WITCH AND IT IS LEAVING HER UPSET AND DISTRESSED.

INF REPORTING CONCERNS FOR HER NEIGHBOURS DUE TO ONE OF THE MALES SUFFERING FROM MENTAL HEALTH ISSUES KNOCKING ON DOORS, CAUSING DAMAGE AND TELLING OTHERS THEY WERE DOING WITCH CRAFT AND AFFECTING HIS ENERGY. *SECTION 40(2) EXEMPTION APPLIED*

INF IS REPORTING ISSUES WITH HIS ADULT SON, SAYING HE IS RUNNING IN AND OUT OF HIS BUNGALOW AND HAS BEEN PRACTISING WITCHCRAFT ON HIM. *SECTION 40(2) EXEMPTION APPLIED*

IP STATES THERE IS NOW A WITCH HUNT AFTER HIM. *SECTION 40(2) EXEMPTION APPLIED*

IP IS REPORTING CONCERNS REGARDING THEIR SON WHO IS HAVING A MENTAL HEALTH CRISIS. HE FEELS LIKE HE HAS A DEMON THAT IS SEXUALLY ABUSING HIM ALL THE TIME. *SECTION 40(2) EXEMPTION APPLIED*
