Request - You asked us the following:

From the 1st January 2021 to the 1st November 2024 how many reports of drug use in schools did Staffordshire Police receive. Please divide the data up into four categories - 1st January 2021 - 31st December 2021, 1st January 2022 - 31st December 2022, 1st January 2023 - 31st December 2023 and 1st January 2024 - 1st November 2024.

If possible, I would also like information on what the drug(s) involved in each incident were.

Please also include how many of these reports led to confiscation of drugs.

We received your request on 18/11/2024 and have processed this under the Freedom of Information Act (FOIA).

Staffordshire Police's response to your enquiry is as follows:

Staffordshire Police holds the requested information.

- From the 1st January 2021 to the 1st November 2024 how many reports of drug use in schools did Staffordshire Police receive. Please divide the data up into four categories - 1st January 2021 - 31st December 2021, 1st January 2022 - 31st December 2022, 1st January 2023 - 31st December 2023 and 1st January 2024 - 1st November 2024. – **Disclosed, please see accompanying file titled 'FOI 17483 Drugs in Schools Data.PDF'.**

Please note that this data has been retrieved from a search of our crime/occurrence recording systems for all occurrences with a drugs qualifier whereby the location type has been listed as a school or place of education.

Please note that this data has been provided to the best of our ability, subject to the limitation of current recording protocols and systems/software. Additional offences/incidents may have been recorded during these timescales but are awaiting finalisation and input onto these systems and would not be present within this dataset.

Every effort is made to ensure that the data presented is accurate and complete. However, it is important to note that this has been extracted from multiple sources, developed for specific policing purposes, for

which data extraction methods have not been specifically designed to directly correlate with the terminology of this request. Therefore, the data presented is subject to the inaccuracies and idiosyncrasies inherent in any large-scale recording system.

As a consequence, care should be taken in the interpretation and presentation of this data, so as to not misrepresent the whole or any part of the data disclosed.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Staffordshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Central Disclosure Unit within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by another Decision Maker who is independent from the original Decision Maker. The Central Disclosure Unit will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Decision maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review they should contact the Information
