Request - You asked us the following:

I am writing to you under the Freedom of Information Act 2000 to request the following information:

The total number of mobile phone thefts from a person received in the three years set out below (November to October):

November 2021 – October 2022
November 2022 – October 2023
November 2023 – October 2024
Number of reports of mobile phone theft from a person

The total number mobile phones reported stolen in theft from a person received in the three years set out below (November to October):

November 2021 – October 2022
November 2022 – October 2023
November 2023 – October 2024
Mobile phones stoles

The total number of mobile phones recovered by the police following thefts from a person in the three years set out below (November to October):

November 2021 – October 2022
November 2022 – October 2023
November 2023 – October 2024
Mobile phones recovered

I would be grateful if you could provide this information in the above formats within an excel spreadsheet. If it is not possible to provide the information requested due to the cost and time involved, please provide advice and assistance, as to how I can refine my request.

We received your request on 21/11/2024 and have processed this under the Freedom of Information Act (FOIA).

Staffordshire Police's response to your enquiry is as follows:

In accordance with Section 17(1) of the Freedom of Information Act, this letter represents a refusal notice for this particular request.

The following exemption has been applied:

- Section 12(1) where the cost of compliance exceeds the appropriate limit. Section 12(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the prescribed limit'.

The above information has been withheld for the following reasons:

There is no method by which we can readily retrieve information from our systems to answer this request. For the time period requested, there have been in excess of 1,500 occurrences of theft from a person. In order to determine whether the item(s) stolen was a mobile phone, each record would require manual review. Further review would need to be conducted in order to determine the total number of mobile phones stolen. Furthermore, for the time period requested, there have been excess of 43,000 items of property seized or recovered, and each of these items would have to be reviewed in order to determine if it conforms with the request and involves a recovered mobile phone.

From dip sampling, it has been estimated that it would take approximately 5 minutes to review each record to answer this request, this would equate to over 125 hours to complete the searches for questions 1 and 2. For question 3, it has been estimated that it would take approximately 5 minutes to review each record to answer this request, this would equate to over 3,583 hours. To achieve this task would therefore exceed the 18-hour time and cost threshold of the Freedom of Information Act by some considerable margin.

Advice and assistance

Section 16 of the Act places an obligation upon the Authority to provide advice and assistance, in order to comply with this obligation please see below.

Unfortunately, we cannot suggest a way in which your request could be simplified or pared down in order to bring it within the confines of the time and cost threshold.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Staffordshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Central Disclosure Unit within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by another Decision Maker who is independent from the original Decision Maker. The Central Disclosure Unit will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Decision maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
