OFFENDER IS IP'S EX-PARTNER. IP HAS REPORTED ONGOING ISSUES WITH OFFENDER SINCE THE END OF THEIR RELATIONSHIP. OFFENDER HAS TRIED TO FORCE THEIR WAY INTO IP'S ADDRESS AND IP HAS HAD TO PUSH THEM OUT. IP HAS SET UP AN ONLYFANS WHICH OFFENDER HAS THEN ACCESSED AND SHARED THE IMAGES ON SOCIAL MEDIA CAUSING IP DISTRESS.	2
IP HAS REPORTED THE POTENTIAL SUSPECT HAS SUSCRIBED TO THEIR PARTNERS ONLY FANS ACCOUNT AND TAKEN SCREENSHOTS OF THE VIDEOS. THE OFFENDER HAS THEN SENT THE PHOTOS TO VICTIM AND THEIR PARTNERS FAMILY IN ORDER TO CAUSE DISTRESS.	2

OFFENDER HAS TOLD THEM TO GET A TRAIN TO MEET THEM, WHERE THEY WOULD PARTAKE IN SEXUAL ACTIVITY. OFFENDER HAS THEN THREATENED IP WHEN THEY REFUSED AND HAS REQUESTED NAKED PHOTOS OF THEM AND TOLD THEM THEY COULD MAKE MONEY ON ONLY FANS AND ASKED IF THEY WANTED TO SELL SOMETHING WHITE.	1
IP HAS DISCLOSED A NUMBER OF INCIDENTS OVER THE PAST FEW MONTHS WHICH ARE CAUSING THEM TO FEEL HARASSED, IP WORKS ON ONLY FANS AND HAS RECEIVED A NUMBER OF FAKE ACCOUNTS CONTACTING THEM REGARDING THEIR WORK.	1
IP HAS REPORTED THAT SUSPECT HAS SENT THEIR PHOTOS WHICH HAVE BEEN POSTED ON ONLY FANS TO A THIRD PARTY INDIVIDUAL	1
THE VICTIM HAS REPORTED SINCE THE RELATIONSHIP HAS ENDED, THE SUSPECT HAS BEEN SENDING CONSTANT EMAILS. THE SUSPECT HAS ALSO SENT A LETTER ADDRESSED TO THE VICTIMS PARENTS WHICH CONTAINED NUDE IMAGES OF THEM. IN THE LETTER THE SUSPECT HAS ACCUSED THE VICTIM OF HAVING AN ONLYFANS ACCOUNT AND CONTAINED AROUND 40 EXPLICIT IMAGES OF THE VICTIM.	1
THE IP HAS REPORTED THAT SOMEONE THEY HAVE BEEN SPEAKING TO ONLINE HAS BECOME TOO MUCH, WITH PERSISTENT MESSAGING TO THE POINT THAT THEY HAVE BLOCKED THEM, THE SUSPECT HAS NOW CREATED AN ONLYFANS ACCOUNT IN VICTIMS NAME USING THEIR FACEBOOK PROFILE PICTURE.	1
