RACIST COMMENTS MADE TO TAXI DRIVER. *SECTION 40(2) EXEMPTION APPLIED*
IP REPORTS BEING THE VICTIM OF A HATE CRIME DUE TO BEING AUTISTIC. *SECTION 40(2) EXEMPTION APPLIED*
IP REPORTS NOT BEING ALLOWED ACCESS TO REFUSE AREA DUE TO RACE. *SECTION 40(2) EXEMPTION APPLIED*
IP REPORTS SHE IS BEING CONNED BY HER EX-HUSBAND. *SECTION 40(2) EXEMPTION APPLIED*
ONLINE POST BELIEVED TO BE EXPRESSING EXTREMIST VIEWS AND INCITING RACIAL HATRED.
PALESTINE FLAG STICKER STUCK ON SHOP SHELF STATING 'BOYCOTT ISRAELI PRODUCE'. *SECTION 40(2) EXEMPTION APPLIED*

ANTI-SEMITIC BANNER STATING ISRAEL HAVE COMMITTED WAR CRIME AND A NUMBER OF PALESTINE FLAGS HAVE BEEN PUT UP AND ATTACHED TO A FENCE BY UNKNOWN SUSPECTS.

IP REPORTING THAT HE FEELS HE IS BEING DISCRIMINATED AGAINST DUE TO HIS FACE, DISABILITY AND GENDER BY A NUMBER OF ORGANISATIONS INCLUDING THE POLICE AND COUNCIL AND FEELS HE IS GETTING NO SUPPORT.

SUSPECT HAS POSTED VARIOUS IMAGES/MESSAGES ONLINE OF A RACIST AND HOMOPHOBIC NATURE. THERE DOES NOT APPEAR TO BE ANY SPECIFIC VICTIM.

INF HAS REPORTED AND SENT A LARGE AMOUNT OF COLLECTED PERCEIVED EVIDENCE OF A HATE CRIME FROM THE SUSPECT. THE EVIDENCE IS SCREENSHOTS FROM SOCIAL MEDIA POSTS. THESE POSTS ARE OPINION BASED AND DO NOT DIRECTLY THREATEN ANY INDIVIDUAL THEREFORE DOES NOT CONSTITUTE A CRIME AT THIS STAGE.

IP AND OFFENDER HAVE HAD A VERBAL ARGUMENT.

PARENT REPORTS THEIR CHILD IS BEING DISCRIMINATED AGAINST.

REPORTS OF ONLINE VIDEO ABOUT A CHURCH TURNING INTO A MOSQUE. *SECTION 40(2)
EXEMPTION APPLIED*

REPORT OF A GROUP OF YOUTHS USING HOMOPHOBIC LANGUAGE TOWARDS IP. *SECTION 40(2) EXEMPTION APPLIED*
IP REPORTS THERE ARE ONLINE VIDEOS ABOUT A MOSQUE WHERE THE MUSLIM RELIGION IS INSULTED. *SECTION 40(2) EXEMPTION APPLIED*
DURING THE RIOTS, PEOPLE WERE MAKING COMMENTS ABOUT WANTING ISLAM TO LEAVE BRITAIN. THERE ARE NO VICTIMS AS THIS WAS NOT DIRECTED AT ANY SPECIFIC PERSON.
THE SUSPECT HAS ENTERED THE PUBLIC HOUSE AND LATER REFUSED TO LEAVE WHEN ASKED TO DO SO. THE MALE HAS THEN BECAME VERBALLY ABUSIVE TOWARDS THE STAFF MEMBERS.
ONLINE POSTS EXPRESSING SUPPORT FOR ISRAEL AND DISDAIN FOR MIGRANTS WITH FURTHER ALLEGATIONS OF POSTS STATING THAT ANYBODY WHO DISAGREES SHOULD GET BOMBED IN A TERRORIST ATTACK.
REPORTS OF RACIST GRAFFITI ON BINS.
REPORTS THAT A FACEBOOK USER HAS BEEN MAKING POSTS THAT HAVE BEEN DISCRIMINATORY AGAINST CHILDREN WITH DISABILITIES, MIGRANTS AS WELL AS POSTS THAT DENOTE RACIAL HOSTILITY AND PREJUDICE.
REPORTS OF RACIST COMMENTS MADE ON SOCIAL MEDIA. *SECTION 40(2) EXEMPTION APPLIED*

SOCIAL MEDIA COMMENTS MADE TARGETTING MEMBERS OF JEWISH AND PALESTINIAN COMMUNITIES. *SECTION 40(2) EXEMPTION APPLIED*
THIRD PARTY REPORT OF A GROUP OF SUSPECTS BEING RACIALLY ABUSIVE TOWARDS IP, THIS IS WAITING FOR VICTIM CONFIRMATION.
INDIVIDUAL USING RACIST LANGUAGE WHILST ON A CALL TO THE POLICE. *SECTION 40(2) EXEMPTION APPLIED*
THIRD PARTY REPORT OF A DELIVERY DRIVER BEING RACIALLY ABUSED BY THE PERSON BEING DELIVERED TO.
REPORT OF AN ANTI-SEMITIC FLYER ATTACHED TO RAILINGS ON A PUBLIC PATH.
