I would like to request the following information under the Freedom of Information Act 2000:

1. The number of complaints/reports received by Staffordshire Police regarding anti-social behaviour occurring at the Crooked House Pub site, located on Himley Road, Himley, Dudley, DY3 4DA, between 1st January 2021 and the present (10th September 2024).
2. If possible, in addition to the information requested under point 1 above, please can you provide the number of complaints/reports received for each year of the relevant period, eg. the number of complaints/reports received between 1st January 2021 and 31st December 2021, the number of complaints/reports received between 1st January 2022 and 31st December 2022, and so on.
3. Please provide a brief description of the nature of the complaints, for example, one report of youths entering the site, one complaint of disorder, one complaint about noise etc.
4. Please provide the number of times Staffordshire Police has visited the site in order to investigate complaints or reports it received between 1st January 2021 and the present (10th September 2024).

We received your request on 10/09/2024 and have processed this under the Freedom of Information Act (FOIA).

Staffordshire Police's response to your enquiry is as follows:

As a consequence, care should be taken in the interpretation and presentation of this data, so as to not misrepresent the whole or any part of the data disclosed.
