Please note that summaries of the Modus Operandi have been provided only for those incidents that were recorded as an occurrence on our crime/occurrence recording system.

Please note that this data has been provided to the best of our ability, subject to the limitation of current recording protocols and systems/software. Additional incidences/occurrences may have been recorded during these timescales but are awaiting finalisation and input onto these systems and would not be present within this dataset.

Every effort is made to ensure that the data presented is accurate and complete. However, it is important to note that this has been extracted from multiple sources, developed for specific policing purposes, for which data extraction methods have not been specifically designed to directly correlate with the terminology of this request. Therefore, the data presented is subject to the inaccuracies and idiosyncrasies inherent in any large-scale recording system.

As a consequence, care should be taken in the interpretation and presentation of this data, so as to not misrepresent the whole or any part of the data disclosed.
