Request - You asked us the following:

I would like to clarify how many officers, retired from Staffordshire Police, who are eligible for remedy under the McCloud judgement have been provided their RSS and are able to elect to make their choice under immediate detriment? It would be helpful if you could provide me with the total number of officers eligible under McCloud and have many of that total number are in a position, today, to access their pension via remedy.

We received your request on 24/01/2025 and have processed this under the Freedom of Information Act (FOIA).

Staffordshire Police's response to your enquiry is as follows:

Staffordshire Police holds the requested information.

- I would like to clarify how many officers, retired from Staffordshire Police, who are eligible for remedy under the McCloud judgement have been provided their RSS and are able to elect to make their choice under immediate detriment? It would be helpful if you could provide me with the total number of officers eligible under McCloud and have many of that total number are in a position, today, to access their pension via remedy. – **Disclosed,**
Officers retired from Staffordshire Police eligible for remedy and due an IC RSS (Immediate Choice Remediable Service Statement) – 769
How many have already received their IC-RSS and are able to make their election – 513

Please note that this data has been provided to the best of our ability, subject to the limitation of current recording protocols and systems/software.

Every effort is made to ensure that the data presented is accurate and complete. However, it is important to note that this has been extracted from multiple sources, developed for specific policing purposes, for which data extraction methods have not been specifically designed to directly correlate with the terminology of this request. Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Staffordshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Central Disclosure Unit within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by another Decision Maker who is independent from the original Decision Maker. The Central Disclosure Unit will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Decision maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
