Request - You asked us the following:

Since January 1 1976 - 1979, please disclose the logs for every incident involving unidentified flying object/unidentified aerial phenomena recorded by your force.

Also please disclose the logs that feature at least one of these search terms: 'UFO', 'Alien', 'lights in sky' and 'spaceship'

For each incident log, please disclose:

- * The date and time the incident was reported.
- * The general location it was recorded (I.E. the city/town/village)
- * The incident log, exactly as it was recorded by the force, redacting any identifiable information which may otherwise prohibit disclosure. For example 'Male caller named (REDACTED) reports seeing four flashing lights hovering above his property in (REDACTED) street before a female was beamed into the sky'.

We received your request on 17/02/2025 and have processed this under the Freedom of Information Act (FOIA).

Staffordshire Police's response to your enquiry is as follows:

Staffordshire Police does not hold the requested information.

- Since January 1 1976 - 1979, please disclose the logs for every incident involving unidentified flying object/unidentified aerial phenomena recorded by your force. – **No information held.**
- Also please disclose the logs that feature at least one of these search terms: 'UFO', 'Alien', 'lights in sky' and 'spaceship'
For each incident log, please disclose:

Please note that records of incidents or incident logs are not held prior to 1999.

Please be advised that all Freedom of Information request responses are published on the Staffordshire Police website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Staffordshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Central Disclosure Unit within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by another Decision Maker who is independent from the original Decision Maker. The Central Disclosure Unit will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Decision maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
