Request - You asked us the following:

1. The number of Staffordshire Police officers who are currently (as of the most recent available date) off work due to mental health-related issues (including, but not limited to, stress, anxiety, depression, and PTSD).
2. The total number of working days lost due to mental health-related sickness absence among officers during the 2024 calendar year (or the most recent 12-month period for which data is available).
3. Any policies or support programs currently in place within Staffordshire Police to address mental health and wellbeing among officers.

We received your request on 09/05/2025 and have processed this under the Freedom of Information Act (FOIA).

Staffordshire Police's response to your enquiry is as follows:

Staffordshire Police holds/does not hold the requested information.

- 1. The number of Staffordshire Police officers who are currently (as of the most recent available date) off work due to mental health-related issues (including, but not limited to, stress, anxiety, depression, and PTSD). – **Disclosed, as of 31/03/2025 there were 41 officers off sick.**
- 2. The total number of working days lost due to mental health-related sickness absence among officers during the 2024 calendar year (or the most recent 12-month period for which data is available). – **Disclosed, in the period 01/04/2024 – 31/03/2025 officers off sick for mental health related sickness accounted for 7225 working days lost.**
- 3. Any policies or support programs currently in place within Staffordshire Police to address mental health and wellbeing among officers. – **Partially disclosed, there are no such policies held by Staffordshire Police but there are number of support programs: TRIM, Mental Health First Aiders, Signposting to Oscar Kilo resources, Signposting to an array of publically accessible mental health resources and support from the Occupational Health Welfare Team.**

Please note that this data has been provided to the best of our ability, subject to the limitation of current recording protocols and systems/software.

Every effort is made to ensure that the data presented is accurate and complete. However, it is important to note that this has been extracted from multiple sources, developed for specific policing purposes, for which data extraction methods have not been specifically designed to directly correlate with the terminology of this request. Therefore, the data presented is subject to the inaccuracies and idiosyncrasies inherent in any large-scale recording system.

As a consequence, care should be taken in the interpretation and presentation of this data, so as to not misrepresent the whole or any part of the data disclosed.

Please be advised that all Freedom of Information request responses are published on the Staffordshire Police website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Staffordshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Central Disclosure Unit within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by another Decision Maker who is independent from the original Decision Maker. The Central Disclosure Unit will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Decision maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review they should contact the Information
