Request - You asked us the following:

We have done a lot of work on E-scooters (see link) <https://www.pacts.org.uk/pacts-expertise-e-scooter-safety/>

and have been trying to track deaths related them. We have come across a death of pedestrian that we understand is in your patch that we were unaware of.

My request is as follows;

1. In 2024, possibly December 2024, did Staffordshire Police report a fatal collision in which a pedestrian was killed by an e-scooter?
2. If so, please provide the date, street and town, and STATS19 / Acc_Ref number.
3. If so, were criminal proceedings commenced, and if so are they complete or ongoing?
4. If so, did Staffordshire Police report the collision to the Coroner, and if so which? Has an inquest been opened or concluded?

We received your request on 10/10/2025 and have processed this under the Freedom of Information Act (FOIA).

Staffordshire Police's response to your enquiry is as follows:

Staffordshire Police holds the requested information.

- 1. In 2024, possibly December 2024, did Staffordshire Police report a fatal collision in which a pedestrian was killed by an e-scooter? – **Withheld, please see below.**
- 2. If so, please provide the date, street and town, and STATS19 / Acc_Ref number. – **Withheld, please see below.**

- Section 21 is an absolute, class-based exemption and as such there is no requirement to quantify the harm that may arise from the disclosure, nor is there a requirement to perform a Public Interest Test.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Staffordshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a Supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Supervisor will reply to the appellant with the result of the review.
