Request - You asked us the following:

Freedom of Information Request - Racial and Religious Hate Crime Data (March 2025 - September 2025)
I am writing to request information under the Freedom of Information Act 2000.

Please provide data on the number of racial and religious hate incidents and crimes recorded by your police force between 1 March 2025 and 2 September 2025, including both violent and non-violent offences, as well as aggravated grievous bodily harm (GBH) where applicable.

For each offence type, please provide:

The raw number of offences recorded that were flagged as racial or religious offences and hate crimes.

The percentage this represents out of all recorded offences of that type during the same period.

A breakdown of the targeted groups, specifying the race or religion of the victims where recorded.

The number of offences recorded that were flagged as racial or religion incidents and hate crimes total in 2024 and the months leading up to March 2025

If available, please break down the data by offence category.

We received your request on 02/09/2025 and have processed this under the Freedom of Information Act (FOIA).

Staffordshire Police's response to your enquiry is as follows:

In accordance with Section 17(1) of the Freedom of Information Act, this letter represents a refusal notice for this particular request.

The following exemption has been applied:

- Section 12(1) where the cost of compliance exceeds the appropriate limit.

Section 12(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the prescribed limit'.

The above information has been withheld for the following reasons:

There is no method by which we can readily retrieve information from our systems to answer this request. Between March and September 2025, there have been in excess of 1,100 occurrences marked as a racial or religious hate crime, or recorded as a non-crime hate incident. In order to determine the targeted group for each offence, the record for each offence would require manual review. To extract this data would therefore require a very labour-intensive manual trawl through each record.

From dip sampling, it has been estimated that it would take approximately 5 minutes to review each record to answer this request, this would equate to over 91 hours. To achieve this task would therefore exceed the 18-hour time and cost threshold of the Freedom of Information Act by some considerable margin.

Advice and assistance

Section 16 of the Act places an obligation upon the Authority to provide advice and assistance, in order to comply with this obligation please see below.

If your request was amended, Staffordshire Police would be able to provide the following:

1. Between 01/03/2025 and 02/09/2025, the number of offences or non-crime hate incidents with either a racial or religious hate flag, broken down by offence and the self-defined ethnicity of the victim (where recorded).
2. Between 01/01/2024 and 28/02/2025, the number of offences or non-crime hate incidents with either a racial or religious hate flag, broken down by offence.

Please note that percentages cannot be provided under the Freedom of Information Act, unless already held in a recorded form.

Please be advised that all Freedom of Information request responses are published on the Staffordshire Police website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Staffordshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a Supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Supervisor will reply to the appellant with the result of the review. If the appellant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
