Request - You asked Staffordshire Police (SP) the following:

Thank you for your response. I just want to clarify I requested the ten people with the most shoplifting offences across the whole period. The response seems to have the top ten individuals by separate years.

I asked the following under question 1: "The top ten individuals with the highest number of recorded shoplifting offences within your police force area between 2020-21 to 2025-26. Split the number of recorded shoplifting offences attributed to them by financial year and provide a total across the period"

Could you please confirm which anonymous individuals are the top offenders across the whole period?

Since this appears like it is being processed as a new request rather than a clarification, I would like you to provide a response to both questions 1 and 2 of my original request. Instead of providing the top offenders by financial year, I would like the top offenders for the whole period but broken down into the number of their offences for each financial year.

1. The top ten individuals with the highest number of recorded shoplifting offences within your police force area between 2020-21 to 2025-26. Split the number of recorded shoplifting offences attributed to them by financial year and provide a total across the period.

2. For each of those individuals, provide the number of offences resulting in charge/summons, caution, no further action split by financial year and a total across the period.

SP received your request on 19/08/2026 and have processed this under the Freedom of Information Act (FOIA).

SP's response to your enquiry is as follows:

SP holds the requested information.

1. The top ten individuals with the highest number of recorded shoplifting offences within your police force area between 2020-21 to 2025-26. Split the number of recorded shoplifting offences attributed to them by financial year and provide a total across the period. – **Disclosed, please see the accompanying file entitled 'FOI 23280 Refinement of FOI 23157 Shoplifting Data'.**

2. For each of those individuals, provide the number of offences resulting in charge/summons, caution, no further action split by financial year and a total across the period. – **Disclosed, please see the accompanying file entitled 'FOI 23280 Refinement of FOI 23157 Shoplifting Data'.**

Please note

- the data differs for Q2 as the outcomes have only been request for charge/summons, caution, no further action. Other outcomes have been removed from this dataset.



- that these figures have been provided to the best of the ability of SP, subject to the limitation of current recording protocols and systems and software. Additional offences may have been recorded during these timescales but are awaiting finalisation and input onto these systems and would not be present within this dataset.

Every effort is made to ensure that the data presented are accurate and complete. However, it is important to note that data is extracted from multiple sources, developed for specific policing purposes, for which data extraction methods have not been specifically designed to directly correlate with the terminology of this request. Therefore, the data presented is subject to the inaccuracies and idiosyncrasies inherent in any large-scale recording system. Consequently, care should be taken in the interpretation and presentation of this data, to not misrepresent the whole or any part of the data disclosed.

All Freedom of Information request responses are published on the SP website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from SP, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the SP response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to forty working days.

The independent supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, considering the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the independent supervisor will reply to the appellant with the result of the review. If the appellant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal. The Information Commissioner can be contacted via the following link:
