Request - You asked Staffordshire Police (SP) the following:

The information below was kindly supplied by the London Metropolitan Police.

It was in response to an FOI, asking them and 5 other police forces as to what data is being collected and collated related to the specific drug detected and measured with respect to RTA Section 5 offence.

The Met responded with tabular data showing which drug, and how often the specified concentration had been exceeded in 2024, and 2025 up to the middle of December.

I am now requesting an FOI from all the other English and Welsh police forces to provide similar data. This information is contained in the Short Forensic Report the police receive from the Forensic Laboratory provider.

If your force is not able to provide this data, please let me know why. Possibly your force is not interested or aware of the increase in Ketamine cases in Section 5a convicted drivers.

To clarify, this is not the number of SFR's issued, as that would give unclear information, this is the number of times that a blood sample sent to our Forensic Service Provider resulted in an outcome that was over the defined legal level under S5 of the Road Traffic Act

SP received your request on 13/01/2026 and have processed this under the Freedom of Information Act (FOIA).

SP's response to your enquiry is as follows:

In accordance with Section 17(1) of the Freedom of Information Act, this letter represents a refusal notice for this request.

The following exemption has been applied:

- Section 12(1) where the cost of compliance exceeds the appropriate limit. Section 12(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the prescribed limit'.

The above information has been withheld for the following reasons:

There is no method by which SP can readily retrieve information from our systems to answer this request. For the time period requested, there are approximately 100 Short Forensics Reports per month that would each need to be reviewed in order to retrieve the data requested. To extract this data would therefore require a very labour-intensive manual trawl through each record.

From dip sampling, it has been estimated that it would take approximately 3 - 5 minutes to review each record to answer this request, this would equate to between 120 and 200 hours. To achieve this task would therefore exceed the 18-hour time and cost threshold of the Freedom of Information Act by a considerable margin.

Advice and assistance

Section 16 of the Act places an obligation upon the Authority to provide advice and assistance, to comply with this obligation please see below.

Unfortunately, SP cannot suggest a way in which your request could be simplified or pared down to bring it within the confines of the time and cost threshold.

Please be advised that all Freedom of Information request responses are published on the SP website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from SP, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to

complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, considering the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Supervisor will reply to the appellant with the result of the review. If the appellant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
