Request - You asked Staffordshire Police (SP) the following:

I'm writing under the Freedom of Information Act to request the following information:

1) For each of the years 2023, 2024 and 2025, the total amount spent by your police force on veterinary bills and the cost of kennelling, in relation to suspected banned dogs.

(If this information is only stored in financial years, please provide it for April 2022-2023, April 2023-2024, and April 2024-2025.)

2) For each of the years 2023, 2024 and 2025, the number of dogs which were euthanised after being seized by the force.

If this request does not fit within cost limits (or other exemptions if you think any apply), please let me know if there are any ways my request could be refined.

I appreciate all your help with this, and look forward to hearing from you within 20 working days.

SP received your request on 15/02/2026 and have processed this under the Freedom of Information Act (FOIA).

SP's response to your enquiry is as follows:

In accordance with Section 17(1) of the Freedom of Information Act, this letter represents a refusal notice for this request.

The following exemption has been applied:

- Section 12(1) where the cost of compliance exceeds the appropriate limit.
- Section 12(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the prescribed limit'.

The above information has been withheld for the following reasons:

There is no method by which SP can readily retrieve information from our systems to answer part of this request. For the time period requested, there have been in excess of 36 invoices. In order to ascertain the veterinary bills and the cost of kennelling, in relation to suspected banned dogs. Each invoice for each month would need to be reviewed. To extract this data would therefore require a very labour-intensive manual trawl through each record.

From dip sampling, it has been estimated that it would take approximately 1 hour 15 minutes to review each invoice to answer this request, this would equate to over 45 hours. To achieve this task would therefore exceed the 18-hour time and cost threshold of the FOI Act by a considerable margin.



Advice and assistance

Section 16 of the Act places an obligation upon the Authority to provide advice and assistance, to comply with this obligation please see below.

In order to assist in refining your request. Data could be provided for the years 2024 and 2025 for the number of dogs which were euthanised after being seized by the force.

Please be advised that all Freedom of Information request responses are published on the SP website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from SP, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, considering the matters raised by the complaint.
