Request - You asked Staffordshire Police (SP) the following:

Consistent with the Freedom of Information Act, please can you provide me with the following information between 01/01/2020 and 31/12/2024:

1. The number crimes at Churches, broken down by type of crime (e.g., arson, theft, assault, etc.), location of the incident, and whether they were treated as hate crimes or religiously aggravated offences.
2. The number of crimes at Synagogues, broken down by type of crime (e.g., arson, theft, assault, etc.), location of the incident, and whether they were treated as hate crimes or religiously aggravated offences.
3. The number of crimes at Mosques, broken down by type of crime (e.g., arson, theft, assault, etc.), location of the incident, and whether they were treated as hate crimes or religiously aggravated offences.

SP received your request on 29/12/2025 and have processed this under the Freedom of Information Act (FOIA).

SP's response to your enquiry is as follows:

In accordance with Section 17(1) of the Freedom of Information Act, this letter represents a refusal notice for this particular request.

The following exemption has been applied:

- Section 12(1) where the cost of compliance exceeds the appropriate limit.
- Section 12(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the prescribed limit'.

The above information has been withheld for the following reasons:

There is no method by which we can readily retrieve information from our systems to answer part of this request. For the time period requested there has been over 460 occurrences in a 'church/religious building'. In order to ascertain whether the offence occurred at a 'Synagogue' or 'Mosque' the record for each offence would require a manual review. Additional research would then be required to determine if they were religiously aggravated offences. To extract this data would therefore require a very labour-intensive manual trawl through each record.

From dip sampling, it has been estimated it would take approximately 5 minutes to review each record to answer this request, this would equate to over 38 hours. To achieve this task would therefore exceed the 18-hour time and cost threshold of the FOI Act by some considerable margin.

Advice and assistance

Section 16 of the Act places an obligation upon the Authority to provide advice and assistance, in order to comply with this obligation please see below.



In order to assist in refining your request, data could be provided from 01/01/2020 to 31/12/2024 where the location has been recorded as a 'church/religious building', and where the address includes the mention of a 'Church, Synagogue or Mosque'. This data can then be broken down by hate crime flag (Yes/No), crime type and location. However, please note this data would only include where the location has been recorded as a 'church/religious building' and further occurrences may have occurred where this field has not been completed.

Please be advised that all Freedom of Information request responses are published on the SP website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from SP, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a Supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.
