Request - You asked Staffordshire Police (SP) the following:

Thanks very much for your response to my request (FOI 22323). Would it please be possible, for a new one, to tell me the length in time in custody (in hours) each of the 44 detainees who were held for over 48 hours were detained for, and their ages at time of detention?

Could you please also confirm:

Whether the figures provided (387 detainees over 24 hours and 44 detainees over 48 hours) relate exclusively to detainees who had been charged and formally remanded in custody by a court (to be transferred to a category B prison, for example), or whether these figures include any pre-charge detention under PACE, or detention prior to a court remand decision (please specify in your response).

Original FOI request

Please log as a refinement of the request for the information regarding detainees held in custody for over 24 hours and over 48 hours for my requested period.

Clarification requested on 28/01/2026:

For the second part of your request, we are unable to say if the detainee was kept in custody at the request of Magistrates or Police. The disposal title is the best description of the reasoning. We can provide the disposal titles of those detainees whose time in custody exceeds 48 hours, please confirm that this information would be acceptable.

Clarification received on 28/01/2026:

In relation to my request - 22338, I can confirm that the information you suggested is acceptable

SP received your request on 08/01/2026 and have processed this under the Freedom of Information Act (FOIA).

SP's response to your enquiry is as follows:

SP holds the requested information.

- Would it please be possible, for a new one, to tell me the length in time in custody (in hours) each of the 44 detainees who were held for over 48 hours were detained for, and their ages at time of detention? - **Disclosed, please see the accompanying file titled 'FOI 22338 Refinement of FOI 22323 Police Custody Data.xlsx'.**

Please note that there are 40 individual detainee records due to different detention periods. Please be advised the times that detainees have spent in custody may have been accumulated over more than 1 detention period as some detainees may have been released and then returned to custody at a later date on the same custody record.

- We can provide the disposal titles of those detainees whose time in custody exceeds 48 hours – **Disclosed, please see the accompanying file titled ‘FOI 22338 Refinement of FOI 22323 Police Custody Data.xlsx’.**

Please be advised that a detainee can have more than one disposal title if they have had more than 1 detention period recorded on the same custody record.

Please note that this data has been provided to the best of the ability of SP, subject to the limitation of current recording protocols and systems/software.

Every effort is made to ensure that the data presented is accurate and complete. However, it is important to note that this has been extracted from multiple sources, developed for specific policing purposes, for which data extraction methods have not been specifically designed to directly correlate with the terminology of this request. Therefore, the data presented is subject to the inaccuracies and idiosyncrasies inherent in any large-scale recording system.

Consequently, care should be taken in the interpretation and presentation of this data, to not misrepresent the whole or any part of the data disclosed.

Please be advised that all Freedom of Information request responses are published on the SP website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from SP, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the SP response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to forty working days.

The independent supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, considering the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the independent supervisor will reply to the appellant with the result of the review. If the appellant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
