I am requesting information under the Freedom of Information Act 2000. Please could you provide the following:

1. The total number of cases of intimate image abuse / revenge porn received by the police force between 31 June 2025 to 1 January 2026.
2. The total number of these cases within this timeframe that were closed with no further action by the police force.
3. The number of cases within this timeframe that were closed without further action due to evidential difficulties
4. The number of cases within this timeframe that were closed without further action because they were not deemed to be in the public interest.

If it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under the Section 16 obligations of the Act, as to how I can refine my request. Thank you.

Clarification requested on 09/01/2026:

We are able to provide the outcomes for the finalised occurrences for the offences of:

- 088/15 - 88C - Sharing intimate photograph or film to cause alarm, distress or humiliation, or for sexual gratification. Sexual Offences Act 2003 Sec 66B (2-3) (10)
- 175/08 - 88C - Share photograph or film of person in intimate state without consent. Sexual Offences Act 2003 Sec 66 B (1) (9)
- 088/15 - 88C - Threaten to share intimate photograph or film. Sexual Offences Act 2003 Sec 66B (4) (10)

We do not record outcomes as 'NFA'. Please confirm that you are happy for us to provide a breakdown by Home Office outcome of the above offences (finalised offences only).

Please be advised that we have provided data from 30/06/2025 – 01/01/2026. Please also note that for question 1, we have included all occurrences, however for questions 2, 3 and 4, we have provided outcomes for finalised occurrences only.

Please note that this data has been provided to the best of the ability of SP, subject to the limitation of current recording protocols and systems/software. Additional offences may have been recorded during these timescales but are awaiting finalisation and input onto these systems and would not be present within this dataset.

Every effort is made to ensure that the data presented is accurate and complete. However, it is important to note that this has been extracted from multiple sources, developed for specific policing purposes, for which data extraction methods have not been specifically designed to directly correlate with the terminology of this request. Therefore, the data presented is subject to the inaccuracies and idiosyncrasies inherent in any large-scale recording system.

Consequently, care should be taken in the interpretation and presentation of this data, to not misrepresent the whole or any part of the data disclosed.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from SP, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the SP response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to forty working days.

The independent supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, considering the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the independent supervisor will reply to the appellant with the result of the review. If the appellant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
