Request - You asked Staffordshire Police (SP) the following:

I ask if you currently, or at any point in the last 5 years, have held or hold a contract with the company Palantir Technologies.

I'll note for the purposes of transparency declarations under the act that this information would not be covered by National Security or law enforcement exemptions, as a recent contract with Leicestershire police has recently been made public voluntarily through the government's contracts finder website, the details of which are here below:

I'd like to know the cost if applicable, as well as the timeframe of the contract, a vague outline of the work (if this can be made available), and if this has the option to extend or not.

I'd also like to know which version of Palantir (IE Gotham) is being used, as well as details of the contract itself please.

I'd like to know as well, if the force has met with Palantir at any point over the last two years to discuss future contracts, if so, can I have the minutes of these meetings please.

SP received your request on 11/03/2026 and have processed this under the Freedom of Information Act (FOIA).

SP's response to your enquiry is as follows:

SP does not hold the requested information.

- I ask if you currently, or at any point in the last 5 years, have held or hold a contract with the company Palantir Technologies. – **No information held.**

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from SP, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the SP response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to forty working days.

The independent supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, considering the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the independent supervisor will reply to the appellant with the result of the review.
