Request - You asked Staffordshire Police (SP) the following:

Please break all of the following down by year (2023, 2024, 2025):

1. The number of recorded offences involving the use of an acid or other corrosive substance against a person.

1a) Where held, the number of those offences that resulted in a sentence.

1b) Where held, the number of those offences in which no custodial sentence was imposed.

1c) Where held, the number of those offences in which no suspect was identified.

SP received your request on 18/03/2026 and have processed this under the Freedom of Information Act (FOIA).

SP's response to your enquiry is as follows:

SP holds the requested information.

Please break all of the following down by year (2023, 2024, 2025):

1. The number of recorded offences involving the use of an acid or other corrosive substance against a person. – **Disclosed, 2023 – nil, 2024 – 1 and 2025 – nil.**

1a) Where held, the number of those offences that resulted in a sentence. – **Disclosed, nil for all years.**

1b) Where held, the number of those offences in which no custodial sentence was imposed. – **Disclosed, nil for all years.**

1c) Where held, the number of those offences in which no suspect was identified. – **Disclosed, 2024 – 1.**

Please be advised that SP do not hold conviction data, but due to the above offence not resulting in a charge and therefore not progressing to court, SP can provide a nil result for questions 1a and 1b on this occasion.

Please note that this data has been provided to the best of the ability of SP, subject to the limitation of current recording protocols and systems/software. Additional offences may have been recorded during these timescales but are awaiting finalisation and input onto these systems and would not be present within this dataset.

Every effort is made to ensure that the data presented is accurate and complete. However, it is important to note that this has been extracted from multiple sources, developed for specific policing purposes, for

which data extraction methods have not been specifically designed to directly correlate with the terminology of this request. Therefore, the data presented is subject to the inaccuracies and idiosyncrasies inherent in any large-scale recording system.

Consequently, care should be taken in the interpretation and presentation of this data, to not misrepresent the whole or any part of the data disclosed.

Please be advised that all Freedom of Information request responses are published on the SP website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from SP, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the SP response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to forty working days.

The independent supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, considering the matters raised by the complaint.
