Request - You asked Staffordshire Police (SP) the following:

Please provide the following information for the latest five reporting years (or, if cost exemptions prohibit it, the latest 12-month reporting period for which data is available):

1. The number of individuals recorded as suspects against offences flagged as involving child sexual exploitation (CSE).

2. Of those individuals in Q1:

A) the number for whom checks were carried out against international policing databases (Interpol, Europol or other relevant international databases).

B) The number for whom such checks resulted in a positive match indicating that they were already recorded on such systems in connection with criminality or policing intelligence.

3. Of those individuals in Q1, how many were in recorded in cases that contained one or more of the following words in your force's records: "vape", "vapes", "vape shop" (total number, no breakdown by specific search term is required)

4. Of those individuals in Q1, how many were in recorded in cases that contained one or more of the following words in your force's records: "convenience store", "corner shop", "off licence", "mini market" and "mini mart" (total number, no breakdown by specific search term is required)

If cost or other exemptions prevent you from providing some of the above information, please provide as much as you are able to within the terms of the Act.

SP received your request on 29/04/2026 and have processed this under the Freedom of Information Act (FOIA).

SP's response to your enquiry is as follows:

In accordance with Section 17(1) of the Freedom of Information Act, this letter represents a refusal notice for this request.

The following exemption has been applied:

- Section 12(1) where the cost of compliance exceeds the appropriate limit.

Section 12(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the prescribed limit'.



The above information has been withheld for the following reasons:

There is no method by which SP can readily retrieve information from our systems to answer this request. For the period requested, there have been more than 1,400 suspects and offenders for offences relating to child sexual exploitation. To determine the number for whom checks were carried out against international policing databases, the number for whom such checks resulted in a positive match and the number that are offences relating to vapes, vape shops or convenience stores, the record for each offence would require a manual review. To extract this data would therefore require a very labour-intensive manual trawl through each record.

From dip sampling, it has been estimated that it would take approximately 30 - 40 minutes to review each record to answer this request, this would equate to between 700 and 933 hours. To achieve this task would therefore exceed the 18-hour time and cost threshold of the Freedom of Information Act by a considerable margin.

Advice and assistance

Section 16 of the Act places an obligation upon the Authority to provide advice and assistance, to comply with this obligation please see below.

If your request was refined, SP would be able to provide the number of individuals recorded as suspects against offences flagged as involving child sexual exploitation (CSE) in the last 5 years. Please be advised, however, that further substantive exemptions may apply.

Please be advised that all Freedom of Information request responses are published on the SP website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from SP, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within 20 working days. In more complex cases the review may take up to 40 working days.

The independent Supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, considering the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Supervisor will reply to the appellant with the result of the review. If the appellant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
