Request - You asked Staffordshire Police (SP) the following:

REQUEST 1:

What would you like to know?: 1. How many BWV cameras are there in your current BWV contract?

REQUEST 2:

What would you like to know?: 2. Who is your current BWV supplier?

REQUEST 3:

What would you like to know?: 3. Who is your current DEMS / RMS provider?

REQUEST 4:

What would you like to know?: 4. When does your current BWV contract expire?

REQUEST 5:

What would you like to know?: 5. Who is your BWV Operational Lead (name and email address)?

SP received your request on 28/08/2026 and have processed this under the Freedom of Information Act (FOIA).

SP's response to your enquiry is as follows:

SP holds the requested information.

1. How many BWV cameras are there in your current BWV contract? – **Disclosed, 1400.**

The figure of 1,400 relates to the number of cameras provided under the new contract and does not represent the number of cameras under the previous contract.

2. Who is your current BWV supplier? – **Disclosed, Axon.**

3. Who is your current DEMS / RMS provider? – **Disclosed, Axon.**

4. When does your current BWV contract expire? – **Disclosed, 30th March 2031.**

5. Who is your BWV Operational Lead (name and email address)? - **Withheld, Section 40.**

The following exemption has been applied:

In accordance with Section 17(1) of the Freedom of Information Act, this letter represents a refusal notice for this request.

- Section 40(2) Personal Information

Section 40(2) is an absolute exemption which means that there is no need to quantify the harm that may arise from the disclosure; neither is it subject to a public interest test.

To release personal or third-party information held by SP, would breach the data protection principles; namely –

- Data is lawfully and fairly processed.
- Processed in line with an individual's rights.
- Data is secure.

Personal and third-party information cannot be released under the Freedom of Information Act.

Disclosure under Freedom of Information is a release of information to the world in general and not an individual applicant.

This data has been provided to the best of the ability of SP, subject to the limitation of current recording protocols and systems and software.

Every effort is made to ensure that the figures presented are accurate and complete. However, it is important to note that data is extracted from multiple sources, developed for specific policing purposes, for which data extraction methods have not been specifically designed to directly correlate with the terminology of this request. Therefore, the data presented is subject to the inaccuracies and idiosyncrasies inherent in any large-scale recording system. Consequently, care should be taken in the interpretation and presentation of this data, to not misrepresent the whole or any part of the data disclosed.

All Freedom of Information request responses are published on the SP website although personal details are not included.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from SP, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing within two months of the date of receipt of this email, and should be addressed to:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Information Access Team within two months of the SP response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing. The review will be conducted by a supervisor who is independent from the original Decision Maker. The Information Access Team will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to forty working days.

The independent supervisor will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, considering the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the independent supervisor will reply to the appellant with the result of the review. If the appellant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
