The Airwave service is a digital radio communications networks designed to meet the needs of the police and other public safety organisations. It is a digital mobile radio service, developed and managed to provide a secure, powerful and flexible communications network.

This policy aims to provide a framework to ensure that all Airwave technology and equipment is deployed as effectively as possible and that correct radio procedures and language are used at all times.

The policy is underpinned by procedures designed to provide clear, definitive and unambiguous direction for all those involved in its delivery.
